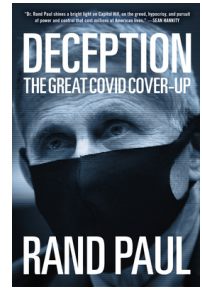


Deception, The Great Covid Cover-Up

This book is extremely insightful as it examines the events surrounding the Covid outbreak and our response to it. And while the book is written by US Senator Rand Paul (a Republican), he does not mince words when it comes to calling out some from his own Party at times.

The book is not simply opinions of the author ... it incorporates direct quotes from a large number of medical experts and most importantly virus experts. The book runs over 400 pages, but it moves quickly and in a captivating manner. The average American will have their eyes opened wide when reading some of the book's revelations.

Following are just a few key points brought out in the book. I do not site page numbers as in most of these instances the material is presented serially throughout the book as the information unfolds. Most insightful of all are email exchanges between scientists and medical/virus experts. Also helpful was the acquisition of Twitter by Elon Musk, allowing us to see many revealing exchanges that went on through the Covid episode and that were previously concealed.

This is not a witch-hunt that simply seeks to expose Dr. Fauci. It is an account of how the narrative was controlled by those in key positions – especially Dr. Fauci. The author's motivation is to prevent such improprieties in the future, and to create transparency for the American people.

While I sensed much of what is revealed by instinct as I personally watched the Covid news unfold – I was nonetheless SHOCKED by the magnitude of the deception that was imposed upon the American people.

Early on the CDC was concerned that Covid might have started in the Wuhan lab. This concern was shared by a few of those researchers closest to Dr. Fauci. Interestingly, the head of the CDC was subsequently excluded from Fauci-led meetings to discuss Covid.

The cover-up begins in January 2020 when those that were concerned about Covid's origins inexplicably changed course in a matter of days, now saying it did *not* originate in the Wuhan lab. Why was this so important? To protect the funding of research being done in the Wuhan lab!

Fauci had great power to approve funding for various kinds of research. And when it came to the research being done concerning "gain-of-function", he bypassed the approval process on at least one occasion and gave approval on his own.

"Gain-of-function" involves the modification of an animal virus to make it easier to infect a human. This one was an eye-opener to me and causes great concern. There is a push to identify all known viruses in the animal world, and using gain-of-function methods these viruses are altered to allow them to attack humans. Presumably this is to prepare vaccines ahead of time to be ready for all conceivable deadly viruses. A major proponent and funding source for this scheme is Bill Gates. Even without considering the great risks involved, especially opening us up to possible terrorist activities if the research falls into the wrong hands, many scientists in the book weighed-in that there has never been an animal virus that NATURALLY evolved into a dangerous human virus. Also consider the risk that this research presents, especially with it being done, among other places, IN COMMUNIST CHINA!

Despite his denials, Fauci approved the funding of gain-of-function research, and this research was being done IN CHINA. Communist China! Not considered a friend and trusted ally to the USA, and certainly not known for transparency – why China?

There is great conflict of interest in scientific reporting. Because of the power he wields (not the least of which is the approval or denial of funding), Fauci had the ability to silence opposing views, presenting only the reports he deemed appropriate with no dissenting perspectives.

Censorship abounds in the science community. Some later recanted and came out in agreement with the silenced alternative perspectives. But largely, opposing voices in science were silenced; and their dissenting reports disappeared.

The author was also critical of some within the GOP who took the big government position and approved a huge funding package that created unnecessary damage to the economy, with accompanying national security implications.

There were arbitrary restrictions imposed on business, especially damaging to small businesses and favoring larger businesses. Some small businesses that were damaged never recovered.

At times information was “classified” for no other reason than to hide dissenting perspectives from the public. These were not sensitive secrets being “classified,” as was later brought out in email exchanges that were released after many Freedom of Information Act requests.

Daily death counts were run by the media, and Covid deaths included the number dying from other causes if they ALSO tested for Covid. Cancer, heart disease, traffic accidents! These inflated numbers were used to keep the average citizen in fear and fully dependent on “the experts.”

Pfizer’s lobbyist worked to censor Twitter feeds that supported the benefits of natural immunity.

Big Pharma paid “royalties” to researchers including Fauci’s teams. Fauci and others refused to provide details on recipients and the amounts paid. There is no transparency. We are unable to see possible financial influences that may be introducing bias to “science.” Clearly, the routing of funding is done in a very clandestine way – with a select few making funding decisions (like Fauci) while also receiving “royalties.”

The same public officials promoting the vaccine mandates received over \$400 million from vaccine manufacturers in the form of “royalties.”

National emergency powers were invoked in many states, using strategies that were questionable as to their benefit. The author was especially critical of a few, including the Governor of my own state, Kentucky. Many of his emergency edits were later deemed unconstitutional – though not before significant damage was inflicted on Kentuckians.

Late in the book (page 356) we read of a bombshell report being released. Contrary to Fauci’s repeated denials, the US government *has* been funding genetic manipulation of coronaviruses not only at Wuhan Institute of Virology but also at a Chinese military research facility.

A number of medical scientists stated that masks are not effective in terms of preventing spread of the virus.

Late in the book (page 407) an important fact was finally revealed – the first-ever Covid case was in Wuhan. This sheds light on something that Fauci tried his best to conceal; the source of the virus was likely the Wuhan lab. While Fauci insisted it likely came from animals in a food market somewhat distant from Wuhan, the fact is that of the MANY animals that were tested NONE showed any evidence of Covid. Considering that the virus originated in Wuhan, coupled

with the fact that the researchers in the Wuhan lab were working on gain-of-function experiments on, among others, coronaviruses ... conclusions to be drawn seem rather apparent.

Regarding natural immunity, any research showing its effectiveness (and most often showing a superior effectiveness to any vaccine) was silenced.

Any research showing natural recovery in younger age groups was silenced. The push was only for the vaccine – one size fits all.

Adverse effects of the vaccine were silenced.

In summary, while Fauci and his allies were quick to accuse any contrary views as “conspiracy theories” ... when we consider the deception and censorship that took place we can see where the true conspiracies were taking place ... with Dr. Fauci, and those he huddled around himself. We have heard the term “Deep State” in a derogatory sense, but the way Fauci, Big Money, Big Pharma, and Big Media collaborated to control anything to do with Covid ... I think we are seeing the reality of a “Deep State” at work..

Of greatest concern in all of this ...

- The cover up as to the source of the Covid virus,
- The cover up of all dissenting scientific research and conclusions,
- The dangerous research being done in China, at our expense,
- The conflicts of interest involving big money and its influence on “science,”
- Fauci’s bypassing even what approval process existed to give approvals on his own,
- A carefully orchestrated censorship in the scientific community and facilitated by the media.

- The many email exchanges between the key players in this drama.
- The voices of MANY dissenting scientists finally given voice in this book.

If anyone thinks this book is politically biased, despite the many scientific voices that weigh-in throughout, I will soon be ready to share my notes from another book – this one by a staunch Democrat, Robert F. Kennedy, Jr. He would agree with everything I’ve shared from the Rand Paul book, and is even more scathing in his revelations.
